Subject: Complaint Regarding Alleged Foreign Funding to JLKM During Jharkhand Elections

Respected Sir/Madam,

l am writing to bring to your immediate attention a matter of grave concern regarding the conduct of a political party in Jharkhand, namely the Jharkhand Loktantrik Krantikari Morcha (JLKM), during the ongoing elections in the state.

It has come to light that JLKM is allegedly receiving funds from foreign sources, specifically from Saudi Arabia, during the election period, which is a clear violation of the Model Code of Conduct (MCC).

Such actions not only undermine the integrity of the electoral process but also pose a serious threat to the sovereignty of our democratic system. The use of foreign funds during elections can influence voter sentiment and disturb the level playing field essential for fair elections.

I kindly request the Election Commission to:

- 1. **Investigate the allegations:** Initiate a thorough inquiry into the funding sources of JLKM during this election period.
- 2. **Scrutinize financial records:** Direct the concerned authorities to audit JLKM's financial transactions to trace any irregularities or foreign contributions.
- 3. **Take appropriate action:** If these allegations are found to be true, take stringent action against the party as per the relevant laws and guidelines.

If this finds true then JLKM parties' registration should be cancelled immediately and Jairam Mahato & his party must be debarred from the electoral process & also votes of first phase on 13^{th} November should not be cast.

I trust the Election Commission to uphold the sanctity of our electoral process and ensure transparency and fairness in the elections. I urge your esteemed office to treat this matter with urgency and keep the public informed about the progress of this investigation.




